The business was founded in 1962 and previously listed on the London Stock Exchange from 1997 to 2021. Aggreko was acquired by TDR Capital and I Squared Capital in August 2021.

Who is the CEO of Aggreko energy?

In November 2021, the company appointed Blair Illingworth as its chief executive. In September 2022, Aggreko launched a new business unit in North America called Aggreko Energy Transition Solutions, which will develop, own and operate clean energy and sustainable infrastructure.

When did Aggreko become a company?

Aggreko was founded in The Netherlands by Luc Koopmans in 1962. It moved to Scotland in 1973. In 1984, it was acquired by Christian Salvesen plc in 1984, a Scottish transport and logistics company. In 1997, the business demerged from Christian Salvesen and then listed on the London Stock Exchange.

What is Aggreko Power?

Aggreko is the world's largest temporary power company. It has more than 10 gigawatts of power across its fleet globally. The company employs over 6,000 people and operates across the world in more than 200 locations in 80 countries and has offices in every continent.
