What does AGSI+ stand for?

The GSE Transparency Platform (AGSI+) of Gas Storage Europe (GSE) has been extended to include storage data for Naftogaz of Ukraine. AGSI+is the name of the platform. With this addition, AGSI+expands its coverage beyond EU 28for the first time.

What is AGSI & Alsi?

As a voluntary initiative by storage and LNG operators, it can be considered as a benchmark to monitor pan-European filling levels for storage and send-out by LNG terminals. 100% of the market of underground gas storage in the EU27 is covered on AGSI and 100% of EU27 large-scale LNG terminals are listed on ALSI.

What is Gie AGSI & TP?

The Agency for the Cooperation of Energy Regulators (ACER) published an in-depth report on the Gas Storage Regulation ,and GIE AGSI +TP was one of their main sources of information for providing key storage indicators per country.

Dr Axel Wietfeld, President of Gas Storage Europe (GSE), the European association of the Storage Operators and hence one column of Gas Infrastructure Europe (GIE), stated: "Underground gas storage facilities have played a pivotal role in ensuring EU security of supply during the cold spell. If we take the example of Germany, in the last few weeks, 61% of gas ...

Following Russia's invasion of Ukraine in early 2022 and resulting international sanctions, natural gas imports from Russia to Europe declined drastically to well below their historical averages (Figure 1). ... We estimate storage capacity using AGSI/GIE data on working gas volumes, converted to billion cubic meters.
