Where is Cenovus Energy located?

Cenovus Energy Inc. (pronounced se-n?-vus) is a Canadian integrated oil and natural gas company headquartered in Calgary, Alberta. Its offices are located at Brookfield Place, having completed a move from the neighbouring Bow in 2019.

Where is Cenovus based?

Cenovus's downstream operations include upgrading, refining and marketing operations in Canada and the United States. Our shares trade under the symbol CVE and are listed on the Toronto and New York stock exchanges. We're a Canadian-based integrated energy company headquartered in Calgary.

What will Cenovus Energy's downstream operations look like in 2024?

Downstream operations are set to improve with anticipated crude throughput between 650,000 and 685,000 bbls/d, a 4% increase from 2024. Investments will focus on safety, maintenance and reliability enhancements across Cenovus Energy's refineries.

What will Cenovus Energy Invest in?

Investments will focus on safety, maintenance and reliability enhancements across Cenovus Energy's refineries. Canadian refining throughput is expected to be between 100,000 and 105,000 bbls/d, with U.S. refining throughput projected in the range of 550,000-580,000 bbls/d.

Where is Cenovus oil & natural gas located?

Cenovus once held conventional oil and natural gas operations across Alberta and Saskatchewan, including the Weyburn oilfield in Saskatchewan, which is the largest CO₂ enhanced oil recovery operation in Canada.

What assets does Cenovus own?

Cenovus's current conventional assets include the Deep Basin, a liquids-rich natural gas fairway located in northwestern Alberta and northeastern British Columbia, and the Marten Hills heavy oil project. The Deep Basin asset comprises approximately 2.8 million net acres of land and produced more than 125,000 barrels of oil equivalent.
