Why did ExxonMobil Open Equatorial Guinea?

ExxonMobil's work here has also helped open Equatorial Guinea for investment from other oil and gas majors and independent companies, including Chevron, Marathon Oil, Kosmos Energy, Panoro, EG LNG, Africa Oil Corporation, Trident Energy, etc.

What happened to Exxon's oil output in Equatorial Guinea?

Exxon's oil output in Equatorial Guinea, a member of the Organization of the Petroleum Exporting Countries (OPEC), peaked at more than 300,000 bpd eight years ago and has been declining since. Exxon has been trying to sell its Zafiro operation since 2020.

Does Equatorial Guinea want a foreign company to take over Exxon?

The Exxon situation is a case in point. Equatorial Guinea wanted a foreign company to take over the assets from Exxon and has been wooing international oil companies including Eni, the Italian producer, and several Nigerian companies, according to a former senior US official familiar with the matter. None have shown any interest so far.

What happened to Exxon & GEPetrol?

Before the incident, Exxon pumped 45,000 barrels a day out of the country; afterwards it dropped to 15,000 b/d. These are small numbers by Opec standards, but Exxon's production was a significant proportion of Equatorial Guinea's total output of 52,000 b/d. The company's assets will be transferred to GEPetrol, the national oil company.

Despite Exxon's history of doing business in Equatorial Guinea for almost three decades, the company decided to cut its losses altogether after a safety incident in 2022 decimated its output.
