The utility electricity sector in Bangladesh has one national gridoperated by Power Grid Company of Bangladesh with an installed capacity of 25,700 MW as of June 2022. Bangladesh 's energy sector is not up to the mark. However, per capita energy consumption in Bangladesh is considered higher than the production.

How much electricity does Bangladesh produce?

Bangladesh's total installed electricity generation capacity (including captive power) is 25,700 MW. It was 15,351 megawatts (MW) as of January 2017 and 20,000 megawatts in 2018. The largest energy consumers in Bangladesh are industries and the residential sector, followed by the commercial and agricultural sectors.
