What are the requirements for a Belarus Visa?

has at least two blank pages intended for visas; ? valid for at least 90 days after the expected departure date from the Republic of Belarus; ? not dubious in terms of authenticity or ownership; ? contains no torn pages, marks, entries, erasures and corrections that are not certified by the issuing authorities of the respective foreign state;

When should I apply for a Belarusian visa?

The Consular Section of the Embassy strongly recommends to apply for visa NOT EARLIER than six months before your visit to Belarusand not to make any irrevocable travel plans prior to obtaining visa. Belarusian entry visas upon arrival at Minsk National Airport

What documents do you need for a Belarusian visa?

For tourism -- one of the following documents in original: A letter of visa support of a Belarusian tourist company, stating that the foreign citizen will respect the rules of stay in the Republic of Belarus. It must be issued on a letterhead with the full name of the tourist company, its location and telephone number.

What is a Belarus Visa?

A Belarus visa is a permit to travel to the country, enter and remain for a limited period, under specific purposes. The competent Belarus authorities grant the permit to applicants that meet the criteria and are asserted not to be a threat to the security of Belarus. Who Needs a Visa for Belarus?

How much does a Belarus Visa cost?

You will get an answer on your application after 5 days of submission, the latest. The Belarus visa fees, regardless of the visa type of the number of entries as EUR80 individual visa applications and EUR10 per person for group visa applications. Belarus Visa fees for nationals of a few countries are a bit different though.

How many types of Belarusian visas are there?

There are three typesof Belarusian visas according to the intended number of entries: Single entry visa. It enables its holder to enter Belarus only once, stay and depart, within a specified number of days of stay, but not more than 90 days. Double entry visa.
