How many countries does Canada trade in energy?

International trade of energy is a vital part of the Canadian economy. Canada traded energy with 158 countries in 2019. Canada exported energy products to 142 countries in 2021. The U.S. accounts for 91% of energy exports by value (\$139.8 billion). Canada imported energy products from 114 countries in 2021.

What is the value of bilateral energy trade with Canada?

Although the value of bilateral energy trade with Canada has varied over the last decade, the overall energy trade balance has changed relatively little, with U.S. energy imports from Canada consistently exceeding U.S. energy exports to Canada by a large margin.

How will Canada-US energy products trade be maintained?

Cross-border pipelinestransport crude oil and bitumen and refined petroleum products between Canada and the United States, and the construction of new projects such as the Line 3 Replacement and Keystone XL (currently shelved by the Biden Administration) will be critical to maintaining these trends in Canada-US energy products trade flows. 4.

What are Canada-US energy products trade flows?

The second largest commodity in the Canada-United States energy products trade flow over the past two decades is natural gas; a cumulative total trade value of \$426.3 billion in that product has passed between the two countries, including \$12.1 billion in 2019.

What is the largest commodity in Canada-US energy trade?

Over the past two decades, crude oiland bitumen was the largest commodity in the Canada-United States energy trade flow at a value of over \$1.1 trillion, followed by natural gas (\$426.3 billion), and refined petroleum energy products (\$253.7 billion) (see Table 1a). According to the United States Energy Information Administration:

How much is energy trade between Canada and the United States?

Over the past two decades, the cumulative aggregate value of the energy products trade between Canada and the United States was \$1.96 trillion, including \$138 billion in 2019.
