While there are many cargoes that can self-heat,ignite a fire and put the crew and ship at risk,the Felicity Ace accident drew specific attention to the potential dangers of transporting lithium-ion (Li-ion) batteries and electric vehicles (EVs) on cargo ships.

What is the world's first electric container ship?

Chinese company Guangzhou Shipyardlaunched in 2017 the world's first electric container ship,putting it in commercial use a year later. As reported by Quartz,the 70m-long and 14m-wide tanker has a battery system made up of more than 1,000 lithium-ion batteries and supercapacitors,giving the vessel the autonomy to travel up to 80km.

Does AIDA ship have a lithium-ion battery system?

Energy storage solutions provider Corvus Energy has supplied German cruise line AIDA Cruises with a 10,000kWh lithium-ion battery system,the largest pack to ever be delivered to a ship. The battery was installed this year on the company's AIDAprima cruise ship,which can carry more than 4,000 passengers and cruise members.
