Vivo Energy Group (BRVM:SHEC,SEM:SHEL) is in the processof acquiring the assets of Engen (BSE:ENGEN) in nine African markets bringing the group's presence in Africa from 15 to 24 countries. The transaction is pending regulatory approval.

Who owns Vivo Energy?

Vitolhad been a shareholder in Vivo Energy since the latter's creation in 2011 as part of Shell's plan to sell downstream operations in Africa. Vivo originally was a joint venture amongst Vitol, Shell and London-based private equity firm Helios Investment Partners, which operated in Africa.

Will Petronas sell Engen to Vivo Energy?

At the combination's completion, Malaysia's Petronas will sell its 74% shareholding in Engen to Vivo Energy. The Phembani Group, Petronas' longstanding partner in Africa and Engen's B-BBEE (Broad-Based Black Economic Empowerment) Shareholder, will remain a 21% shareholder in the South African business.

Why did Vivo Energy buy Engen?

Stan Mittelman,CEO of Vivo Energy,stated that the deal forms efforts by the firm to expand its footprint across Africa's energy sector, with the company doubling its size since formation in 2011. "Four years ago, we acquired the Engen business in nine African markets, and have since worked to enhance and develop these.

How many Engen-branded service stations will Vivo Energy have in Africa?

The transaction is pending regulatory approval. Upon completion of the transaction, nine new countries and more than 300Engen-branded service stations will be added to Vivo Energy's network, taking its total presence to more than 2.100 service stations across 24 African markets.
