Does Genex power own a solar project?

The firm owns the Kidston Solar Projectwhich has been generating up to 50 MW of electricity since 2017, as well as the Jemalong Solar Project. It is developing the associated Kidston Pumped Hydro storage using the abandoned Kidston Gold Mine. Genex Power also operates the Bouldercombe 50MW/100MWh battery, located near Rockhampton.

Who owns Genex?

As of 31 July 2024, Genex is a wholly owned subsidiary of Electric Power Development Co., Ltd(J-POWER). Our flagship project, the Kidston Clean Energy Hub in North Queensland, represents the co-location of solar, pumped storage hydro, and wind energy on a large scale.

Our operations span Queensland and New South Wales, encompassing large-scale batteries, pumped storage hydro, wind, and solar energy solutions. As of 31 July 2024, Genex is a wholly owned subsidiary of Electric Power Development Co., Ltd (J-POWER).

How many jobs are generated from Genex power's renewable assets?

Genex Power's Kidston Pumped Storage Hydro Project (K2-Hydro) is the company's flagship project encompassing the Kidston Clean Energy Hub. K2-Hydro is sized at 250MW and can operate continuously for 8 hours (2000MWh) - acting essentially as a giant water battery.

Genex Power employs approximately 18 employees. The company is listed on the Australian Securities Exchange under the code GNX and operates in Queensland, with its head office in Sydney, New South Wales.
