

Does Georgia have any free trade agreements?

Georgia has free trade agreements with several countries. It has free trade regimes with the Commonwealth of Independent States and Turkey. In June 2014, Georgia signed an Association Agreement and a Deep and Comprehensive Free Trade Area with the EU. Georgia also signed a Free Trade Agreement (FTA) with China in 2017, and in 2018, it signed an FTA with Hong Kong.

Does Georgia have a free trade agreement with the EU?

Georgia has a Deep and Comprehensive Free Trade Area agreement with the EU, which grants duty free treatment for more than 7,000 products. The EU also grants Georgia GSP+ treatment. Georgia also has free trade regimes with countries of the Commonwealth of Independent States and Turkey.

Does Georgia have a duty free export policy?

Georgia is eligible to export many products duty-free to the United States under the Generalized System of Preferences (GSP) program. Both countries signed a Bilateral Investment Treaty in 1994 that stipulates this benefit.
