What is the Guam Energy Office?

The Guam Energy Office provides energy efficient technical assistance to consumers and businesses, aiding them in implementing cost-effective energy efficiency actions. It also offers policy and input analysis, as mentioned in the passage.

How is energy consumed in Guam?

In Guam, the consumption of energy is heavily influenced by its remote location. Almost all energy is reliant on imports of petroleum products for use in transport and electricity. Guam does not have any domestic production of conventional fuels such as oil, natural gas, or coal.

When will the Guam Energy Office reopen?

The Guam Energy Office will reopen for business starting Monday, June 1, 2020 from 8:00 am to 5:00 pm. Effective June 1, 2020, all GovGuam offices, agencies, and departments will recommence public operations. Continued compliance with Social Distancing rules will be strictly enforced, thus services will be limited to those with appointments only.

Does Guam have a power outage?

Over the past months, Guam has been having rolling power outages. GPA is still coping with the loss of about 80MW of reserve power generation capacity since Cabras 3 and 4 were damaged in an explosion.
