

#### What is the Presidential Cabinet of the Marshall Islands?

The Presidential Cabinet is as follows: The legislative branch of the government of the Marshall Islands consists of the unicameral Legislature (Nitijela) with an advisory council of high chiefs. Legislative power lies with the Nitijela. The Council of Iroij is an advisory body composed of 12 tribal chiefs.

Who is the president of the Marshall Islands?

The Judiciary is independent of the executive and the legislature. H.E. Hilda C. Heine, first woman and current president of the Marshall Islands, walking through the Memorial Amphitheater at Arlington National Cemetery Sept. 12,2017. The president is elected by the Nitijela from among its members.

What type of government does the Marshall Islands have?

Governance occurs in a framework of a parliamentary representative democratic republic, and of an emerging multi-party system, whereby the President of the Marshall Islands is both head of state and head of government. Executive power is exercised by the government. Legislative power is vested in both the government and the Nitijela (Legislature).

#### What does the Marshalls Energy Company do?

"The Marshalls Energy Company is a semi-autonomous utility company responsible for the generation, distribution and sale of electricity a number of islands and atolls within the Republic of the Marshall Islands."

How does the Republic of the Marshall Islands work?

It allows islanders to live and work in the United States, and establishes economic and technical aid programs. The Republic of the Marshall Islands has four court systems: Supreme Court, High Court, district and community courts, and the traditional rights court.

Are there political parties in the Marshall Islands?

Elections in the Marshall Islands are officially nonpartisan, though candidates could be affiliated with one of the active political parties. There are currently four political parties in the Marshall Islands: Aelon Kein Ad (AKA), Kien Eo Am (KEA), United People's Party (UPP), and United Democratic Party (UDP).

Legislative: Legislative power resides in the Nitijela, which consists of 33 senators elected by 24 electoral districts by universal suffrage of all citizens above 18 years of age. The electoral districts correspond roughly to each atoll of the Marshall Islands.
