In August 2016, Emerson announced the sale of the Network Power business to Platinum Equity and a group of co-investors. Headquartered in Columbus, Ohio, the company is a leading provider of thermal management, A/C and D/C power, transfer switches, services and information management systems for the data center and telecommunications industries.
