Who owns Markbygden ETT wind farm?

Norwegian aluminium producer Norsk Hydro ASA (OSE:NHY) has been notified that Markbygden Ett AB, the owner of the 653-MW Markbygden ETT wind farm in Sweden, has entered a company reorganisation process. Markbygden Ett AB's application for reorganisation was granted by the district court of Umea on Tuesday, Norsk Hydro said.

How many wind farms does RWE own?

We operate around 760 MW (RWE share ~600 MW) of onshore wind farms. We own and operate one out of Sweden's only twooffshore wind farms,Kårehamn. Our renewable energy production development portfolio has a potential of around 11 GW*.
