### Which power plants produce the most electricity in Romania?

Hydroelectric power plantsare the main source for electricity production in Romania. In 2022, they accounted for 25.28 percent of total electricity generation. This was followed by nuclear power plants, which made up 20.04 percent of electricity production that year. Get notified via email when this statistic is updated.

How many power plants are in Romania?

The main electricity generation plants are state-owned: Cernavoda Nuclear Power Plant,208hydropower and pumping plants, and six coal-fired power plants. In June 2023,Romania produced 4.412 TWh of electricity. Transmission of Energy

Does Romania have a nuclear power plant?

Romania has two operational nuclear reactors at the Cernavod? Nuclear Power Plant, which contribute a significant portion of the country's electricity, but also significant natural gas reserves and production facilities, making it a key player in the regional natural gas market.

Will Romania achieve a decarbonised energy sector by 2040?

In contrast, the investments outlined in Romania's National Energy and Climate Plan (NECP) do notensure a decarbonised energy sector by 2040. The Romanian power sector would emit 9.2 MtCO2 in 2030 (which can be halved in a lower-gas scenario) and 3.5 MtCO2 in 2040, at slightly higher wholesale electricity prices.

Does Romania have a competitive advantage in wind production?

Romania appears to have a regional competitive advantage in wind production. The market value of wind remains higher than that of solar for all modelled years, while lower wind investments are expected in Hungary and Bulgaria.

Currently, less than 1% of Romania's energy comes from wind. At the end of 2008, there was a total of 10 MW of wind power capacity installed in the country, out of the approximate 65 GW of total installed wind capacity in the EU. In order to ensure the development of wind energy in Romania, the country's grids will need to be significantly ...
