3. Vatican City. The Vatican City is not part of Italy or Rome. The Vatican is the last true remnant of the Roman Empire. The State of Israel is also said to be a Roman outpost. The Vatican's wealth includes investments with the Rothschilds in Britain, France and US and with oil and weapons corporations as well.

Pope Francis on Saturday issued a new constitution of the Vatican City State that further emphasizes the power of the pope over the sovereign state. The new constitution, called "the Fundamental Law of Vatican City State," is the third in history and replaces a law promulgated by St. John Paul II in 2000.

The Fundamental law of the Vatican City State of 13 May 2023 defines legislative and executive functions as follows: "LEGISLATIVE FUNCTION" ARTICLE 7. The legislative function, except in cases that the Supreme Pontiff intends to reserve to himself, is exercised by the Pontifical Commission of Vatican City State. ARTICLE 8

The Vatican City State remains, in the end, the pope's domain. Nonetheless, the new law suggests that the city-state is no longer merely considered a support to the Holy See but an entity closer to the secular and modern states, as it has never been in the past.

However, the first materialistic steps were made only in 2008, when 2,400 solar panels were installed on the roofs of the Vatican's Paul V Hall. It produces over 300 MWh per year. Also, in 2016, the Vatican upgraded and renovated its recycling system, and in 2023 it adopted electric vehicles in partnership with Volkswagen.

The term of the current president of the Vatican Tribunal, judge Giuseppe Pignatone, will end in 2024. Pignatone has played a key role in the Vatican finance trial since its first hearing in 2021. The new changes to Vatican City State's penal law and judicial system take effect on April 13.

As in the 2000 Law, the Pope confirmed &quot;the fullness of the power of government&quot; of the Supreme Pontiff &quot;which includes legislative, executive and judicial power&quot;. The &quot;singular peculiarity and autonomy of the Vatican juridical system&quot; are also reaffirmed. The latter is distinct from that of the Roman Curia.

The canon law of the Catholic Church is supreme in the civil legal system of Vatican City State. The Supreme Tribunal of the Apostolic Signatura, a dicastery of the Roman Curia and the highest canonical tribunal, is also the final court of cassation in the civil legal system of Vatican City State.
