Did Freudenberg buy XALT Energy?

The parties have agreed not to disclose the purchase price. Freudenberg had already acquired a majority stake the US battery manufacturer XALT Energy,LLC,Midland,Michigan,USA,in 2019. The company develops and produces lithium-ion battery cells and fully integrated battery packs for the commercial vehicle and maritime industries.

What is XALT Energy and the ReCell Center?

XALT Energy,LLC,and the ReCell Center,the U.S. Department of Energy's Vehicle Technologies Office's (DOE/VTO) battery recycling center, are closing a technology gap between the world's increasing use of lithium-ion batteries and the need for advanced, in-process and end-of-life battery recycling options.

Who is XALT Energy?

The company develops and produces lithium-ion battery cellsand fully integrated battery packs for the commercial vehicle and maritime industries. XALT Energy employs around 550 people in Midland and Auburn Hills, Michigan.

What can XALT Energy offer for me?

XALT Energy, a company by Freudenberg Sealing Technologies, is offering material resources and proof-of-concept testing validate a simple separation process that allows for direct recycling of manufacturing scrap electrode materials into new battery electrodes, in collaboration with the ReCell Center.

What does xalt's new Gigafactory deal mean for commercial vehicles?

The XALT gigafactory in Midland will assemble the battery cell modules for electric commercial vehicles as part of that contract. This deal will create new jobs at the XALT factory in Midland, as well as other XALT sites in the U.S, to "meet the increasing demand from our customers," Freudenberg said.

Will Freudenberg E-Power Invest in Midland xalt?

Midland's XALT factory can expect to see large investments from Freudenberg e-Power company in the years ahead. On Feb. 2 the company announced it would invest a "double-digit million sum in the expansion" of its battery business and capacities. This investment would go partially into the Midland XALT factory, and there's more to come.
